"It's fun to be able to be on the cutting-edge of science and technology and use my skills and interests in a slightly different manner than the traditional engineering route," Libby says. Patent law combines her favorite aspects of science in a different arena. "Some of the parts I like about science and engineering are also present in the law, like analytical and creative thinking."

Outside of the scientific aspects of her practice, Libby also works to protect her clients' branding through trademarks. This includes registration as well as enforcement of trademarks. "Trademarks are an important part of my clients' business," she says. "Trademarks can allow a business to convey so much meaning to their customers, and we need to make sure that meaning is not interfered with."

Prior to joining Nyemaster, Libby worked as a patent attorney at a large international law firm in Washington, D.C., at the heart of U.S. patent law. "I had a wide range of sophisticated clients when I was in D.C.," Libby says. "Every client is different, so you have to make sure you have that personalized approach."

Now, Libby applies the skills she has learned to achieve her clients' goals. "I'm a firm believer that we should always be questioning and thinking," she says. "I work within the constraints of laws and regulations and think about how to best apply those for the client even if it's not the path most regularly taken."
